

# Winnebago County Health Department COVID-19 Data by School District Geographic Boundary

September 9, 2021

COVID deaths and hospitalizations are increasing. Get vaccinated & wear a mask

#### Summary

- Due to a <u>high level</u> of community transmission of COVID-19 in Winnebago County, the health department strongly <u>recommends</u> that everyone, vaccinated and unvaccinated, <u>wear a mask</u> in public indoor settings and crowded outdoor venues.
- The Delta variant has led to more COVID-19 infections, hospitalizations and deaths and the unvaccinated are most at risk. Vaccination provides the best protection against the highly contagious Delta variant. If you are unvaccinated, continue to wear a mask, social distance and make a plan to get vaccinated. If you are vaccinated, you still may bring the Delta variant home to unvaccinated or immune suppressed family and friends. Protect yourself, family and friends by encouraging vaccination and wearing a mask.
- Schools are a high risk setting with the Delta variant circulating. To help keep schools open, have your child wear a mask, stay home when ill, and test after an exposure to COVID-19 or someone who is ill. If your child is ill or has been exposed to COVID-19, keep all other children in your household home as well.
- The Pfizer COVID-19 vaccine has been proven <u>safe and effective</u> with <u>full FDA approval</u> for the prevention of COVID-19 disease in people 16 years of age and older and is still authorized for use in those 12-15 years of age. - Employers should implement multi-layered interventions to protect workers and mitigate the spread of COVID-19. Employers

- Situational Awareness:
  - The confirmed + probable case burden is very high for our jurisdiction. The confirmed + probable case rate over the past 2 weeks for our jurisdiction is 457.9 cases per 100,000 people, an increase from the 433.2 cases per 100,000 reported in last week's report.
  - Over the past two weeks, we have reported a total of 704 confirmed + probable cases, a 5% increase compared to the 666 confirmed + probable cases reported in last week's report.
  - o There are at least 558 PCR tests being performed every day in our jurisdiction, and this is trending upwards.
  - o Over the past two weeks, 7.2% of PCR tests were positive in our jurisdiction. The percent positivity has continued to increase each week since our lowest point in mid-June.
  - There are currently 70 COVID-19 patients hospitalized in Fox Valley Area hospitals. New evidence is emerging that the Delta variant may produce 30-50% higher hospitalization rates than previous variants. Due to the latest surge, hospitals in the Fox Valley region are nearing capacity for staffed hospital beds, including ICU beds. Over the summer, hospitalizations due to COVID-19 were the lowest they had been since the start of the pandemic, dropping all the way down to zero hospitalizations on July 9. Hospitalizations have now increased significantly over the past two months, and have almost tripled in the past month.
- Current COVID-19 activity level is indicated as <u>very high</u> for Winnebago County based on a very high burden status over the past two weeks. As long as the virus is still circulating, children under the age of 12 and all other unvaccinated individuals are at a higher risk of getting COVID-19.
- With the current surge in positive tests, our ability to do contact tracing is strained. Only the highest risk close contacts are being
  contacted directly by public health we are asking people that test positive for COVID-19 to reach out to all other close contacts
  themselves.
- Vaccines are available any day of the week at a <u>site near you</u>. Visit <u>www.wcvaccine.org</u> to find answers to your questions about
  the vaccine and see where you can get vaccinated. Get your first dose before September 20 and get \$100!
  - o 62.4% of Winnebago County residents aged 12 or older have received at least one dose of the COVID-19 vaccine.
  - Everyone 12 and older is eligible to receive the COVID-19 vaccine. Pfizer is the only vaccine currently approved for 12- to 17year-olds. Check vaccine locations before you go if you need or want a specific vaccine brand.
- COVID-19 testing remains an important tool in reducing spread of the virus to others. Whether you are vaccinated or
  unvaccinated, get a COVID-19 test if you have symptoms, were exposed to the virus, or feel you need a test. Knowing helps you
  protect others. Even if you have no symptoms or mild symptoms, you can infect others.
  - o The CDC encourages widespread testing to identify asymptomatic cases to avoid the spread of COVID-19.
  - Sunnyview Expo Center PCR test results currently take approximately 3 days. <u>Visit our website</u> for a full list of testing locations in Winnebago County.

## Confirmed Cases by School District Geographic Boundary for the Past Two Weeks (August 25 – September 7)

There have been 521 new confirmed cases reported in the past two weeks within the geographic boundaries of the Neenah, Omro, Oshkosh, and Winneconne School Districts. An additional 44 confirmed case reported was within the geographic boundaries of other school districts that only partially fall within our jurisdiction.


### Confirmed Case Counts Among Individuals under Age 18, Trended Over Time by School District Geographic Boundary






The graphs on the following pages show how case rates by age group have changed over time for Oshkosh and Neenah School District boundaries. The first graph on each page shows the biweekly confirmed case rates per 100,000 residents. The second graph shows the cumulative confirmed case rates. Cumulative case rates will always trend upward, it is the rate of increase in that trend that helps us understand what populations are being impacted the most. Omro and Winneconne do not have similar graphs due to small population size and small confirmed case counts in these geographic areas.









#### OSHKOSH AREA SCHOOL DISTRICT GEOGRAPHIC BOUNDARY







#### **Background Information**

This report provides *preliminary* data on the confirmed COVID-19 cases from August 25, 2021 – September 7, 2021. A person is counted as a confirmed COVID-19 case if they had a positive confirmatory laboratory test (for example, polymerase chain reaction (PCR) tests or nucleic acid amplification tests (NAAT) that detect genetic material of SARS-CoV-2, the virus that causes COVID-19). Antigen positive tests are counted as probable cases and are not currently included in the case count rates and graphs in this report. Please view the General Weekly Data Report to learn more about the confirmed and probable case counts, rates, and burden level.

Dates utilized for all graphs and tables are based on test result date and may not represent final reported case counts. Data may be underreported for recent days because results can take multiple days to be reported to the health department. This means the number of tests and percent positivity may change in next week's report. As this is a weekly report for the past 14 days, there will always be a week of overlap between reports.

Data by school district geographic boundary may differ from data provided by the respective school district. School district geographic boundaries are the geographic area from which children are **eligible** to attend a certain school district. Data by school district geographic boundary includes cases among all individuals that live within that boundary regardless of age or where they attend school. In this report, data for school age children (5-17) does not differentiate between where they actually attend school or if they are homeschooled.

\*The COVID-19 data provided in this report is specific to the Winnebago County Health Department (WCHD) jurisdiction (population: 153,748). It does not include the portions of the City of Menasha or City of Appleton that fall within Winnebago County as those areas fall within the jurisdiction of the City of Menasha Health Department and City of Appleton Health Department. As of October 3, 2020, data reports from the Winnebago County Health Department do not include test results from residents in Wisconsin Department of Corrections facilities, which includes the Oshkosh Correctional Institute. This data can be found on the Wisconsin Department of Corrections website.

Data provided on the <u>Department of Health Services website</u> may be different than the information provided by WCHD because the state reports data for the entire county based on address, which includes those portions of Menasha and Appleton as well as the correctional facilities.
