Jeff Bucholtz called the meeting to order at 9:30 AM.

Guest Speaker's:

Tracy Rosinski & Deb Wiliams with ProMedica:

PROMEDICA provides home health care (skilled care), palliative care, hospice care, and emotional/spiritual support. They will meet the veterans needs at where they are: home, assisted living, nursing home. Their focus is to create a care plan that will improve their quality of life; they will meet the individual's needs. They have a whole care team, nurses, social workers, bereavement counselors, pastors, volunteers... The PROMEDICA Team is trained to help their veterans die healed. They have the desire to help unburden the veteran. They also want to help the spouse be the spouse during this time, and not just the caretaker. They also offer bereavement counseling for 13 months after the loved one passes away.

PROMEDICA does have a contract with the VA. This means that the VA will cover the cost if the veteran is enrolled in VA Health Care.

The financial benefits that are available by utilizing PROMEDICA are numerous, and is definitely worth the time looking into.

PACT ACT:

Jeff discussed how the PACT ACT is slow going because of the huge influx of claims that have been submitted. He also brought up that a lot of these disabilities have been coming back with a 0% rating. Hypertension is one of the disabilities that have been coming back rated at 0%. This is OK!!! We can get secondary conditions off of ANY primary condition even if the primary condition is only rated at 0%.

Also, the VA is sending out letters to veterans and spouses who have been denied previously because the PACT ACT expanded the contaminated areas. If you hear of veterans or their surviving spouses questioning the legitimacy of the letter, please assure them that it is from the VA and that they should contact us to help file a claim.

Health Care had a 5 year window for veterans who came home from deployment. If that window was missed, they base eligibility for VA Health Care off of income. The PACT ACT opened up this window BRIEFLY!!! **This window closes October 2023**. **PLEASE SPREAD THIS WITH YOUR POST!!!!**

Burn Pits: what they are referring too is typically Gulf War Era Veterans. The Burn Pits for Vietnam Veterans are not presumptive conditions. We understand that is mentioned under the PACT ACT, but the PACT ACT, when referring to Burn Pits, is focused on Gulf War Era Veterans.

Camp Lejeune Justice ACT: There are times that we believe that Lawyers are necessary for certain claims. If a veteran who served at Camp Lejeune is diagnosed with a *presumptive* condition, then file a claim with the your CVSO via the VA, not an attorney. You cannot do a claim with the VA for a *presumptive* condition and then turn around and get a cash settlement from the government via an attorney. But, if your spouse or children were stationed there with you while at Lejeune, then they should definitely reach out and contact an attorney to help them with their lawsuit if they have any of the conditions they believe may have been caused by the toxic water.
