Check the Municipality Drop Down. If the first 3 digits are in this drop-down list, do **NOT include them in the parcel number field.

IF a balance is outstanding a **red** "Pay Taxes" button will be available to select. If no balance is due, this button will be gray and you cannot select it.



⚠ Please note that payments tendered through this portal will be assessed a one-time convenience fee based on the total amount due. Convenience fees are in addition to the amount(s) owed on property taxes and are calculated as follows:

- A 2.20% convenience fee will be charged for payments using Visa, MasterCard, American Express or Discover credit cards. The convenience fee is based on the total amount due.
- A \$3.95 convenience fee be charged for payments using debits cards.
- A \$0.25 convenience fee be charged for payments using e-check.
- You will have the opportunity to review the total amount due with the convenience fee prior to payment submission.
- While you will be paying fees to Winnebago County, the full amount of the convenience fee is passed to Municipal Services Bureau (MSB) as the provider of this online payment service.

Make Payment

You will then be prompted to select the method of payment you wish to make and then select "Make Payment" to be routed to enter the necessary information pertaining to the method of choice.
