Medicare Part D-MEDICARE PRESCRIPTION DRUG COVERAGE

Open Enrollment October 15 - December 7 every year.

25 Part D plans offered in WI Standard Benefit: \$445 Deductible - then plan pays 75% you pay 25%. When total drug costs are \$4,130 the donut hole begins. You pay 25% for both brand name and generic drugs while in the donut hole. Donut hole ends when beneficiary pays a total of \$6550 in drug costs - then catastrophic coverage occurs and beneficiary pays only small copay or coinsurance amount

Income Level 3- \$1,610.00/mo (\$19,320/yr) single

Partial Subsidy, \$92.00 deductible, 15% co-insurance

Medicaid Purchase Plan (MAPP) This program is for individuals who are receiving SSDI (SSA disability payments) and are working at least one hour or more per month. They may be eligible for health care coverage through the WI Medicaid Program. A premium payment may be required for this health care coverage. Asset limits also apply.
