

Site plan for a proposed house and garage on Poplar Ct. (Blacktop). The plan shows a 186.0' wide lot with a 10' wide grassed area, a 137.0' wide channel, and a 6' deep swale. The proposed house is 38' wide and 24' deep, with a 12' setback to the side lot line. The proposed garage is 22' wide and 22' deep, with a 20' setback to the side lot line. A well is located near the house, and a sump pump discharge is shown. The plan also indicates a 50' setback to the road right-of-way and a 57' setback to the road right-of-way for the garage area.
