## ALL AGENDA ITEMS ARE ACTIONABLE

- A. Winnebago Waterways Program reminder that there are 2 recovery efforts going on Winnebago Waterways and Keepers of the Fox
- B. Katie Reeds funding moving forward DNR grant was awarded, March 2024 Dec 2027. Will continue with the shoreline restoration program and aquatic plant education and will advance more on HAB (Harmful Algal Bacteria) reporting and education.
- C. Streambank inventory update: Rat River Extrapolated numbers have been approved by the working group, working on the last 3 streambank extrapolations.
- D. Breakwall construction/funding update total grant awarded for project was \$1,219,000. Working with funders for extensions, looking at alternatives.
- E. Town of Calumet potential new project the Town Runoff Reduction Committee is looking at developing an Enhanced ARTS at the bottom of the escarpment. Developing the project to go after grant

opportunities.

- F. Water level management update even with the warmer winter and low precipitation, the lake levels have come up the past 2 weeks due to recent precipitation. Hoping to get a good plant survey to get good data from this year's plant response.
- G. Climate Smart Agriculture grant update administrative challenges have delayed the rollout of the program. Learning from earlier Climate Smart awardees of some complications to set up the farmer contracts correctly. All but Waushara has hired the agronomist. First meeting with the counties will be held at the end of April.
